The following is a list of the misdemeanor and traffic misdemeanor bailbond schedule set by the Supreme Court and the Sixth Judicial district sorted by statute number. Fish and Game offenses are listed in category order beginning on page 4. The *italicized* area are those offenses which qualify for a written plea of guilty over-the-counter, according to Idaho Misdemeanor Criminal Rule 14(a) and Misdemeanor Criminal Rule 14(b). **FOR YOUR INFORMATION, A PERSON CITED FOR STALKING, I.C. 18-7906; DOMESTIC ASSAULT OR BATTERY, I.C. 18-918; VIOLATING A DOMESTIC VIOLENCE PROTECTION ORDER, I.C. 39-6312; AND VIOLATION OF A NO CONTACT ORDER, I.C. 18-920, CANNOT BOND OUT OF JAIL UNTIL A BOND IS SET AT ARRAIGNMENTS.** For all misdemeanors not appearing on the bailbond worksheet, bond is set at \$300.00 according to Sixth District Administrative Rule 92-10.
