I understand that I may revoke this consent at any time by submitting to the Bannock County Commissioners’ office a written document signed by me and notarized, except to the extent that action has been taken in reliance on it, and that unless consent is sooner revoked, this release is valid as long as it is pertinent to this application. I also understand that if I revoke this consent to the extent it prevents or substantially interferes with the completion of the investigation of my application, it may result in my application being denied.
