OFFICIAL BALLOT SUPPLEMENTAL LEVY ELECTION
MARSH VALLEY JT. SCHOOL DISTRICT #21 BANNOCK and CARIBOU COUNTIES, STATE OF IDAHO

The purposes for which the proposed levy revenues will be used and the approximate amount of levy funds to be allocated to each use are as follows:

Purpose Approximate Amount Allocated
Salaries \$582,000
Curriculum \$200,000
Special Populations (Special Education and Gifted and Talented Programs) \$100,000
Arts Programs and Activities (Band, Choir, Visual Arts, Student Council, etc.) \$20,000
Athletics \$42,000
Facilities \$156,000
Total \$1,100,000

QUESTION: Shall the Board of Trustees of Marsh Valley Jt. School District #21, Bannock and Caribou Counties, Idaho, be authorized and empowered to levy a Supplemental Levy in the amount of One Million One Hundred Thousand Dollars (\$1,100,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2023 and ending on June 30, 2025, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on July 3, 2023.

The estimated average annual cost to the taxpayer on the proposed Supplemental Levy is a tax of \$49 per \$100,000 of taxable assessed value, per year, based on current conditions.
