**NOTICE IS HEREBY GIVEN THAT THE BANNOCK COUNTY COMMISSIONERS** are seeking to fill one (1) vacancy on the Planning and Development Council.

The Planning and Development Council serves as a volunteer body and makes decisions and recommendations on land use development in unincorporated Bannock County. Meetings may include public hearings, business items, or work sessions on various aspects of land use including subdivision proposals, conditional use permits, variances, appeals, and legislative text and map amendments.

Regular meetings are held on the 3<sup>rd</sup> Wednesday of every month in the Office of Planning and Development's Conference Room located at 5500 South 5<sup>th</sup> Avenue, Pocatello, Idaho. Additional meetings are held as needed.

**REQUIREMENTS:**

In accord with Bannock County ordinance, members shall have resided within the County for at least four (4) years prior to appointment and must remain a resident for the duration of their service. Duration of term is four (4) years. Members serve without compensation excepting reimbursements incurred in the course of carrying out Council duties.

**PREFERENCE:**

In accordance with Idaho Code 67-6504, preference for this open seat on the Council shall be given to individuals who reside outside of incorporated city limits and outside of areas of city impact. Any interested individuals, however, are encouraged to apply.
